Many hijras drop out of primary school because of their experiences of discrimination (Aziz and Azhar, 2020). Bangladesh's hijra minority lives on the periphery of society. with no sociopolitical space to live a dignified life. Their plight stems from their lack of acknowledgment as separate gender human beings outside of the male-female gender binary. They are less likely to find a job in the formal labor market and more likely to live in informal settlements if they have not completed a tertiary degree, Hijra may choose to leave their families to avoid further social exclusion, or they may be forced to leave if their family members object to their lifestyle.

'Hijragiri' or 'badhai' is how most Hijra make a living (Khan et al., 2009). Greetings! Hijragiri, Badhai, or bazaar tola, refers to various behaviors, including collecting money in exchange for blessings, receiving funding from local retailers, and mugging travelers at traffic crossroads, railroad stations, and other public venues. Hijra relies heavily on 'badhai as a stream of income since they realize how fearful people are of being cursed by them and how much faith they have in their magical abilities. 'Hijragiri', a ritual that involves collecting money from shops in the marketplace and dancing and singing for a newborn baby boy in metropolitan areas, is now a part of their daily routine.

In April 2013, Human Rights Watch stated, on the basis of 2016 government data, that around 94.6 per cent of the rape accused were known to the victim as they were either close family or acquaintances. In 2016, there were 106 rapes every day in India. More than 30,000 rapes were reported in India every year, whereas the non-reporting of such crimes is very high owing to the social stigma attached to them.

The Brahminical patriarchy considers rape the violation of the purity of a woman's sexuality and imposes a social stigma on the victim rather than on the perpetrator. In fact, rape and other acts of sexual violence are one of the most under-reported crimes in India, considering the patriarchal values associated with women's sexuality and morality. On the basis of the NFHS 2015-16 data and NCRB data, it was derived that 99.1 per cent of cases of sexual violence go unreported in India as they involve a close relative of the victim. The sexual violence against women by close relatives shows how women's sexuality is controlled and punished accordingly by men.
